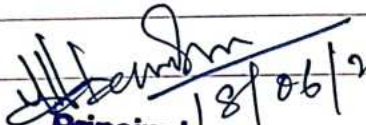

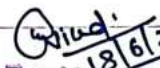

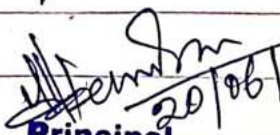
G.B. Meeting, Dt: 20.06.2024.

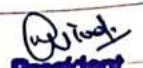
A meeting of Governing Body is held today at 5 P.M in the office of the Principal under the presidentship of G.B President Dr. Govind Agrawal.
